Two priests found unsuitable for ministry due to credible sexual abuse allegations

Archbishop Charles J. Chaput, O.F.M. Cap. has found two priests unsuitable for ministry, including one who served in Bucks County, due to substanti-ated allegations of sexual abuse, the Archdiocese of Philadelphia said in a press release issued Feb. 23.

Chaput deemed the Rev. James
J. Collins, 75, not suitable for ministry following a substantiat-ed allegation that he sexually abused a 17-year-old minor more than 40 years ago, the archdio-cese said. He served at various parishes and schools in Philadelphia.

The archbishop also found the Rev. John P. Paul, 67, unsuitable for ministry following a substantiated allegation that he sexually abused a 17-year-old minor more than 40 years ago, according to the press release. Paul served at Acebbisho W. Wood Wink School. the press release. Paul served at Archbishop Wood High School, Warminster (1997-2000); and Saint Andrew, Newton (1997-2000). He also has served at other parishes and schools in the Philadelphia area. The Feb. 23 announcements are neither connected to one another nor to the cases of priests placed on administrative leave following the February 2011

grand jury report. Collins and Paul were both placed on administrative leave in 2013.
Following Archbishop Chaput's determinations of their unsuitability for ministry, neither Collins nor Paul will have public ministry in the Archdiocese of Philadelphia.
They have the right to appeal the decisions to the Holy See. If they do not appeal, or if an appeal is unsuccessful, they could be laicized (removed from the clerical state) or live a life of prayer and penance.

With the Archdiocesan Policy for the Protection of Children and Young People, promulgated in October of 2012, the allegations against Collins and Paul first were reported to the appropriate local district attorney's office. Upon declination of criminal charges by the district attorney the Archdiocesan Office of Investigations began its investigation in each case. The results of this process were submitted to the Archdiocesan Professional with Consistent

Responsibility Review Board (APRRB), which is comprised of 12 men and women, both Catholic and non-Catholic, with extensive professional backextensive professional back-grounds in the investigation and treatment of child sexual abuse.

It functions as a confidential advisory committee to the arch-bishop, which assesses allegations of sexual abuse as well as allegations of violations of The Standards of Ministerial Behavior and Boundaries. That body provided a recommendation regarding suitability for ministry to the archibishop, who made the final decisions.
